Businesses of any sector are eligible for support of between £5,000 and £20,000, but must be based in Tendring's rural areas, as defined by DEFRA's 'Magic Maps Platform, which is viewable here.

The Business strand includes the following interventions, as per Government's criteria:

- Funding (capital grants) for small scale investment in micro and small enterprises in rural areas. Including
 capital funding for net zero infrastructure for rural businesses, and diversification of farm businesses outside
 of agriculture to encourage start up, expansion or scale up of these businesses where this involves converting
 farm buildings into other commercial or business uses.
- Funding (capital grants) for growing the local social economy and supporting innovation. This includes community businesses, cooperatives and social enterprises and research and development sites
- Funding (capital grants) for the development and promotion (both trade and consumer) of the visitor economy, such as, local attractions, trails and tourism products more generally

Proposals will be assessed against the following criteria:

- Value for Money and/or Added Value to an Existing Project
- Benefit to Residents and/or Businesses

Please be advised that there is a limited amount of funding available, and submission of a project plan does not guarantee that funding from the REPF will be allocated. Applications are being welcomed from 9th June 2025 until 4th August 2025; however no payments will be made to successful applicants until the money is received by TDC from Government.

Eligibility, Submissions and Deadline

Projects which have already benefitted from Rural England Prosperity Funding or the aligned Fund UK Shared Prosperity Fund, are eligible to apply, for a continuation of the same project or a new initiative. However, all applicants should think carefully about how they demonstrate not only the impact of their proposed project, but how it could continue into the future without the availability of REPF beyond this financial year, if appropriate.

The submission deadline is 4th August 2025, and applications will not be assessed formally until after that date has passed. Any outstanding incomplete applications after that date will not be considered.

Subsidy Control
