

# Right to Buy: Financial Information and Anti-Money Laundering Declaration Form

This form is used to consider your eligibility for the Right Buy and should be completed and returned together with the Form RTB1 Application Form. Your application will not be able to be progressed until **BOTH** forms have been received.

Money laundering is any process which is intended to use, control, hide or disguise money or property which is derived from criminal activity and given the appearance of being legitimate.

Tendring District Council is committed to preventing money laundering by having proportionate and cost effective anti-money laundering systems and processes in place.

The Money Laundering Regulations 2017 set out detailed requirements for organisations to establish procedures to prevent its services being used for money laundering.

This declaration must include the names and signatures of each person sharing the Right to Buy. All parties must print their name, sign and date the document.

Failure to do this or to provide any of the required information or supporting documentation may delay your application.

Giving false or misleading information or omitting information for the purpose of gaining the Right to Buy may be regarded as a criminal offence for which action could be taken against you. This could include prosecution and the recovery of the property.
