AGE OF DECEASED - Still born to under 18 years of age

Charges relating to still born children and those aged less than 18 years of age are not made to the bereaved family but instead are 'claimed' against the Government's Children's Funeral Fund.

A claim must be submitted by the Funeral Director, Burial Authority / Cremation Authority within 6 months of the date of the funeral otherwise the applicant will be eligible for the fee.

For deceased that are not still born the Authority will require the date of birth of the deceased.

The Government's Children's Funeral Fund is not available for charges relating to the service of a non viable foetus.

See below for the services a family may claim for via their Funeral director-

- a Up to £300 towards a coffin, shroud, casket or other covering
- b Removal of implanted medical devices for a cremation
- c Completion of necessary cremation certificates on behalf of the medical professional
- d A container for storing ashes in a columbarium or similar (if the one returned to the bereaved family is unsuitable for)
- e Fees charged by a third-party grave digger (where these are not claimed by the burial or cremation authority)

If the application is made 6 months after the funeral the applicant will be eligible for the fee.

Charges relating to the cremation or burial of a non viable foetus cannot be claimed against the Government's Children's Funeral Fund.
